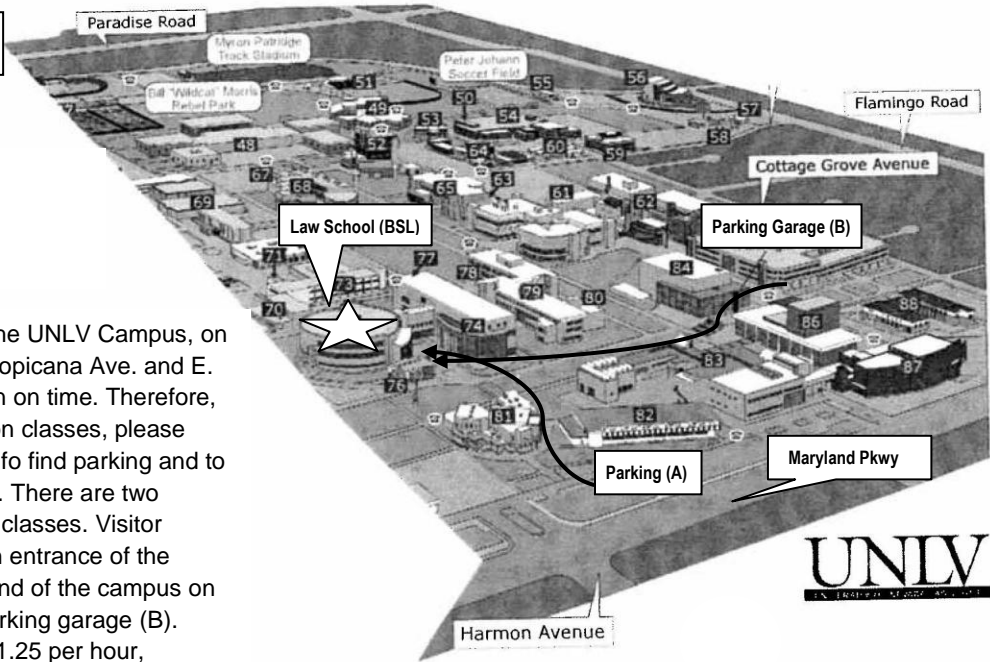


DIRECTIONS

To: UNLV, William S. Boyd School of Law (BSL)

BSL is located in the heart of the UNLV Campus, on Maryland Pkwy. between E. Tropicana Ave. and E. Flamingo Rd. All Classes begin on time. Therefore, when attending Legal Education classes, please allow an additional 15 minutes to find parking and to locate the Law School building. There are two available parking areas for the classes. Visitor parking is available at the main entrance of the campus (A) and on the north end of the campus on the bottom floor of a 5 story parking garage (B). There is metered parking (at \$1.25 per hour, payable in quarters) on Monday - Thursday before 7:00 p.m. and on Friday before 1:00 p.m.



To Park on Maryland Pkwy in Harmon Lot (A): (Best choice for handicap, Saturday and week day)

From Harmon and Maryland Pkwy. at main entrance: Enter right parking lot with parking booth. Before 7:00 p.m. there is metered parking at \$1.25 per hour payable in quarters. After 7:00 p.m. and on weekends, there is no fee. See arrow on above campus map, walk west, pass Richard Tam Alumni Center, and proceed to the Law School.

To Park in Cottage Grove Parking Garage (B): (Overflow parking when Harmon lot is full)

From Maryland Pkwy. and Flamingo traveling south, turn right (west) onto Cottage Grove Ave. Make left at entrance for Judy Bayley Theater. Turn right into Parking Garage at last entrance, marked for "Visitor Parking". Metered guest parking is on ground floor ONLY. Once parked, exit garage at southeast corner (near elevators) and proceed toward Performing Arts Buildings (Judy Bayley Theater and Artemus Ham Hall). Proceed between buildings, past Flashlight sculpture. Continue on same path onto main campus. Law School is third building on the right. See arrow on above map.

To: Legal Aid Center of Southern Nevada, 800 South Eighth Street

Legal Aid Center of Southern Nevada is located in the downtown area, one block off E. Charleston Blvd., between Las Vegas Blvd. and Maryland Pkwy. on the **corner of Eighth Street and Gass Street.**

From I-15, take East Charleston exit. Travel east on Charleston, just past Las Vegas Blvd. Turn left onto 8th Street. Free parking is available along 8th Street.

From I-95, take Las Vegas Blvd. exit. Travel south on Las Vegas Blvd. to Gass Street. Turn left onto Gass Street. Turn right onto 8th Street. Free parking is available along 8th Street.

To: Nevada Legal Services, 530 South Sixth Street

Nevada Legal Services is located in the downtown area, three blocks off E. Charleston Blvd., between Las Vegas Blvd. and Maryland Parkway on the **corner of Sixth Street and Bonneville.**

From I-15, take East Charleston exit. Travel east on Charleston to Las Vegas Blvd. Turn left onto Las Vegas Blvd. to Bonneville. Turn right on Bonneville and left on 6th Street. **Metered parking on street.**

From I-95, take Las Vegas Blvd. Exit. Travel south on Las Vegas Blvd. to Bonneville Street. Turn left onto Bonneville. Turn left onto 6th Street. **Metered parking on street.**
