The International & Comparative Human Rights Practicum, an **ABA-approved** winter intersession program in New Delhi, India, integrates classroom and field experience and exposes law students to comparative and international law themes. Participants will work closely and intensely with a diverse yet small group of students and faculty from both the U.S. and India. The 12-day course includes participation in field placements and completion of a research paper of value to the field placement.

PROGRAM COST: \$3,000

(Includes tuition for 3 credits, room and board, health insurance, and all fees and materials. Travel to and from New Delhi is not included.)

LOCATION

Classes will be held at the Indira Gandhi National Open University School of Law in New Delhi, India.

COURSE DESCRIPTION

This program qualifies for 3 academic credits.
Course topics will include:

- Overview of International Human Rights Law
- South Asia governmental and non-governmental Human Rights Organizations
- Comparative Constitutional Law — India & U.S.
- Individual Rights and Procedures in Criminal Proceedings
- Human Trafficking in South Asia and Its Impact in the U.S.
- Public Defense and Criminal Justice — India & U.S.
- Rights of Children — International and Comparative Law — India & U.S.

Students will give presentations, submit reflective journals, participate in field placements and complete a research paper of value to the placement.

PROGRAM COST

\$3,000 (\$150 tuition deposit applied towards tuition)
