Nevada Gambling Diversion

- Crimes committed in furtherance of a Gambling Problem
- No Violence
- Sanctions ordered by Court which are strict and severe
- Felony can be expunged

- Treatment works
- Addicts are treatable
- Restitution is paid
- Rehabilitation is possible
- If not taken seriously, the addict will put him/herself back in prison

Money is **Not** the Drug




- ACTION is the drug for problem gamblers
- The <u>action</u> is what alters their moods
- Money just makes the "high" sweeter
- No money = temporary quit, or criminal behavior





- **✓** Repentance
- **✓ R**estitution
- ✓ **R**ehabilitation *and*
- **✓ R**ecovery

Smarter Questions = The Rest of the Story

Who Can (BEST) Screen, Assess, Treat G.D.?

- Screen
 - Anyone, including You, with proper tools
 - Health technicians, Office Managers, Family
- Assess and Evaluate
 - Certified Problem Gambling Counselors (CPGC's)
- Diagnose/Treat
 - Licensed or Certified Professional Health Care Personnel: Clinicians with Gambling Training
 - Interns Supervised by Licensed/Certified Supervisors
 - CPGC, CPGC-I; MD, PhD, RN, MFT, LCSW, CPC

Problem Gambling Screening

Lie-Bet Questionnaire

- 1. Have you ever felt the need to **bet** more and more money?
- 2. Have you ever had to lie to people important to you about how much you gambled?

Brief Biosocial Gambling Screen BBGS

- 1. During the past 12 months, have you become **restless**, **irritable or anxious** when trying to stop/cut down on gambling?
- 2. During the past 12 months, have you tried to keep your family or friends from knowing how much you gambled?
- 3. During the past 12 months, did you have such financial trouble as a result of your gambling that you had to get **help with living expenses** from family, friends or welfare?

Responsible Gambling: "Do You Have FAT ABS?"

- Frequency
- Amount
- Time
- Alcohol use (none)
- Buddy system (like scuba)
- Signs



Warning Signs? (Hint: See WTFS trifold)


- Sneaking, Hiding or Lying about gambling
- Change in school or relationship performance because of gambling
- Borrowing money to gamble
- Chasing losses
- Trying to control, cut down or stop without success
- Trying to escape worry or trouble by gambling

ASSESSMENT, defined:


"Those procedures by which a clinician evaluates an individual's strengths, resources, preferences, limitations, problems and needs, and determines priorities so that an individualized treatment plan can be developed."

(The ASAM Criteria, 2013, p. 413)

The GPPC Form

- Demographics
- Dimensional Criteria with Severity Level
- Driving Dimensions
- Vulnerabilities/Strengths
- Suicidality/Threat to Self & Others
- Assessment Instruments & Results
- Reports Made / Consents Given
- Disposition/Follow-up/Appt/Reinterview
- Provisional Tx Plan & Discharge Criteria

Dimensional Criteria


- 1. Frequency/Intensity/Duration of the Disorder
- 2. Biomedical Conditions / Complications
- 3. Cognitive/Behavioral/Emotional Conditions
- 4. Readiness to Change
- 5. History/Potential of Relapse/Continued Problem
- 6. Recovery/Living Environment

Severity Scale

High-Significant Impediment to Treatment

Moderate – Moderate Symptoms

Low – No significant impairment or distress



Our Working Hypothesis

- 3 or more Dimensions rated High
 - May suggest Residential or Inpatient care
- 2 Dimensions rated High
 - May suggest Intensive Outpatient care
- Any Dimension rated High
 - May suggest Outpatient care
- Levels of care (LOC) have varying levels of intensity
