LOCATION

Classes will be held at the National Law University in New Delhi, India.

COURSE DESCRIPTION

This program qualifies for 3 academic credits.

Course topics will include:

- Overview of International Human Rights Law
- South Asia Governmental and Non-Governmental Human Rights Organizations
- Comparative Constitutional Law
- Rights and Procedures in Criminal Proceedings
- Rural Empowerment and Sustainable Development
- Human Trafficking in South Asia and Its Impact in the U.S.
- Refugee and Asylum Issues
- Public Defense and Criminal Justice
- Rights of Children — International and Comparative Law

Students will give presentations, submit reflective journals, participate in field placements and complete a research paper of value to the placement.

PROGRAM COST

\$3,500 (\$250 tuition deposit applied towards tuition)

Program Costs Include tuition for 3 credits, accommodations and meals for 21 days,* health insurance, transportation between New Delhi airport and the university, and course reading packet. Travel to and from New Delhi is not included.

Additional Costs (optional): Excursions may be arranged for break and weekend periods for additional costs.

*The cost of accommodations are included for the period December 18 through January 7, including breaks. Individual arrangements can be made for additional days before and after this period. Accommodations for the participant's spouse/partner can be arranged.
